

## Shipping Checklist

Please refer to the Shipping of Samples page on our website for detailed instructions on how to fill out shipping forms and how to properly package samples.

- Cardboard outer box
- Styrofoam® insert
- Dry ice
  - If shipping from within **Canada**: 5-7 kg (10-15 lbs)
  - If shipping from the **USA**: 6-7 kg (12-15 lbs)
  - If shipping **international/overseas**: 15 kg (33 lbs)

Use packaging that is designed and constructed to allow the release of carbon dioxide gas and to prevent a build-up of pressure in the packaging. *Do not seal the edges of the package with tape!*

Place the following documents **inside the cardboard shipping container** on top of the Styrofoam® lid:

- Packing slip with order number and other relevant client details for identification upon receipt
- A detailed sample list

Affix the following labels to the **outside of the box**:

- Dry Ice Label UN1845 (available from courier)
- Address Label
- For **non-infectious** samples: Exempt Animal Specimen Label *OR* Exempt Human Specimen Label
- For **infectious** samples and if applicable: UN3373 Label
- A clear plastic shipping envelope (available from courier)

Fold and insert the following documents in the clear plastic **shipping envelope** attached to the outside of the box.

- Waybill (minus the top copy which you will keep for your records) supplied by your courier
- 3 copies of the Commercial Invoice (when using)
- 3 copies of the Declaration of Biological Shipments (when using)
- Destination Control Statement (USA)

## Shipping Label

When shipping biological samples for research purposes, it's crucial to ensure compliance with relevant regulations and guidelines to maintain sample integrity and safety. The specific requirements may vary depending on your location, the type of samples, and the destination.

It's important to consult with your institution's shipping department or compliance office to ensure that you are following all necessary protocols and regulations specific to your location and the type of samples being shipped.
